

INITIATIVE OF THE VOLUNTARY PRINCIPLES ON SECURITY AND HUMAN RIGHTS

NGO PILLAR REPORTING GUIDELINES

I. INTRODUCTION

The Participation Criteria of the Initiative of the Voluntary Principles on Security and Human Rights ("Voluntary Principles Initiative") sets forth each Participant's intent to engage in full dialogue on the implementation of the Voluntary Principles. The Criteria further state that each Participant is to report annually to the Plenary on its efforts to implement, and/or assist in the implementation of, the Voluntary Principles.

The purpose of the Reporting Guidelines is to help: (i) support transparency regarding efforts to support and implement, and/or assist in the implementation of, the Voluntary Principles; (ii) assist Participants in reporting on efforts to implement the Voluntary Principles to the Plenary; and (iii) facilitate the exchange of good practices among Participants.

The reports are *not* intended to grade implementation by one Participant against another. Participants are expected to describe their efforts to implement the Voluntary Principles each year recognizing any and all security and legal considerations, as well as practical issues related to the collection of required information.

II. NGO PILLAR REPORTING GUIDELINES

The NGO Pillar Reporting Guidelines are divided into five sections:

- (A) Commitment to the Voluntary Principles;
- (B) Procedures;
- (C) Promotion of the Voluntary Principles;
- (D) Country Implementation; and
- (E) Lessons and Issues.

Sections A-E set forth expected reporting commitments and Section E is optional.

Note that, for some of the Reporting Guidelines, there are detailed Guidance Notes. While these Guidance Notes are optional, robust and fulsome annual reports will take due consideration of them, and seek to incorporate them where applicable and appropriate.



III. REPORTING CONTENT

Reporting Guidelines Guidance Notes Describe how you have engaged in the Voluntary New Nigeria Foundation (NNF) participated actively in the 1 Principles Initiative over the past year. activities of the Nigerian Voluntary Principles In-Country Implementation Working Group including attending several cross-pillar meetings held at Abuja, Nigeria. The Foundation also participated during the visit of the VPI to Nigeria in January 2018. We worked with the NGO pillar to develop a communication document that was used for public awareness during the visit. NNF also participated in NGO Pillar calls organised by both the VP Secretariat and Nigeria NGO Pillar and stakeholders. The VPI Secretariat developed a training manual on the VPs in the period under review and NNF did a pilot in Lagos, Nigeria using the material. Describe efforts to increase transparency, both internally NNF's engagements, activities and efforts on the VPI were 2 and externally, regarding your efforts to implement or prominently published on the Foundation's newsletter, website and its MD's report to NNF Board. The Foundation also conducted support implementation of the Voluntary Principles. training of men and officers of the Nigeria Police Force. The training was used to introduce Voluntary Principles to Nigeria Police Force in Lagos. NNF developed an innovative programme called **Brutality Tracker** to support citizens reporting of human rights violation by personnel of the Public Security Forces.

NNF conducted a training for 52 persons (29 females and 25 males) from various units of the Nigeria Police Force, Lagos State Command in attendance. At the end of the training, the capacity of the participants with respect to Human Rights was enhanced and awareness of the Nigeria Police Force, Lagos State Command on the voluntary principles; its human rights framework; human rights ethics and responsibilities in compliance with the VPSHR and relevant policies regarding



		human rights and ethical conduct was increased.

NNF engaged the Lagos State government through the Ministry of Energy and Mineral Resources to adopt the VPs approach following the discovery of crude oil deposits in the state. The essence of this effort is for the state to proactively guard against the negative experiences in other regions of the country.

The Foundation embarked on a visit to the Nigeria Security and Civil Defence Corps (NSCDC) Lagos Command in July 2018 to create awareness on the VPs to the Commandant and Officers of the Corps. We also discussed training of personnel of the Corp.

13	Lessons or issues from this reporting year, as well as plans or opportunities to advance the Voluntary Principles for the organization	The training programme for the Nigeria Police Lagos Command and NSCDC could not progress after the first batch as a result of lack of funds. The first training was funded wholly by NNF. Also, we could not deploy the Brutality Tracker mentioned earlier as a result of funding challenges.
		In the coming year, we hope to advance these plans as funds are secured.
